GENERAL INFORMATION

The University of Hawaii is a multi-campus system of postsecondary educational institutions serving the State of Hawaii . The University of Hawaii at Manoa, on the island of Oahu, is the major comprehensive graduate and research campus with more than 18,000 students. The campus is located on 300 acres of land in lush green Manoa Valley, a residential section close to the heart of metropolitan Honolulu, the state capital. This location offers easy access to the center of the commercial, cultural, and political life of Hawaii.

The University of Hawaii at Manoa began in 1907 as a land-grant college of agriculture and mechanic arts called the College of Hawaii . In 1912, the school moved to its present location, and with the addition of the College of Arts and Sciences in 1920, became the University of Hawaii.

Throughout its history, the University has emphasized studies related to the distinctive geographical and cultural attributes of Hawaii. Geographical location generates interest in oceanography, marine

sciences, Asian and Pacific studies, and interdisciplinary studies of tropical environments, problems, and resources. The physical characteristics of Hawaii focus academic attention on such areas as tsunami research, volcanology, astronomy, and astrophysics. The state's multi-ethnic culture and close ties to Asia create a favorable environment for the study of various aspects of diverse cultural systems, including subjects such as linguistics, genetics, philosophy, and international relations.

More than 200 of the University's activities have an international dimension. In addition, the Manoa campus ranks among the leading American institutions of higher education in terms of numbers of foreign scholars on its staff and foreign students enrolled in its numerous colleges.

In all, the University offers course work leading to bachelors in 89 fields of study, masters in 87, doctorates in 53, first professional degrees in law and medicine, and a number of certificates.

APPLICATION SUBMISSION PERIOD

FALL 1998 applications are accepted from October 1, 1997 to January 1, January 15, February 1, February 15 or March 1, 1998 (see deadlines below).

SPRING 1999 applications are accepted from May 1 to August 1, or September 1, 1998 (see deadlines below).

APPLICATION PROCESS

These instructions have been prepared to assist applicants to the University of Hawaii at Manoa Graduate Division. They are to be used in conjunction with the enclosed admission application.

The application process begins when an application is submitted to the Graduate Admissions Office. The Admissions Office is responsible for collecting applications and supporting documents, establishing a file, and evaluating the academic credentials. Notification of any missing credentials required by the Graduate Division is sent within four weeks of the receipt of that application.

Applications that meet the Graduate Division's requirements are forwarded to the graduate program requested by the applicant, where they are subjected to a more comprehensive review. Recommendations for admission are made by departmental admissions committees to the Graduate Admissions Office which sends the official offer. This process is guided by policies established by the Graduate Division.

Additional information about the Graduate Division and the graduate programs offered at the University of Hawaii at Manoa appears in the General and Graduate Information Catalog (see below). Information given here supersedes information contained in the General and Graduate Information Catalog. Before completing the application, please read these instructions carefully. All information is subject to change without notice.

Criteria For Admission: Applicants for admission to advanced degree programs must hold a bachelor's degree from a regionally accredited United States college or university, or its equivalent from a recognized foreign institution of higher learning. The standards of the foreign degree in question must be equivalent in both the distribution of academic subject matter and in scholarship achievement requirements to those maintained at the University of Hawaii. Applicants from Bangladesh, Burma, India, Nepal and Pakistan who do not hold a 4-5 year bachelor's degree must present a completed master's degree at the time the application is filed. Generally, an applicant must have a grade point average of 3.0 (4.0=A scale) or the equivalent, in the last four semesters or 60 semester credits (or the equivalent in quarter credits) of the undergraduate record and in all postbaccalaureate work.

Admission Status: When a student is admitted, the admission status is only valid for the program and semester to which the student is accepted. If the student does not enroll in the semester admitted, and wishes to be considered in a subsequent semester (within a 2-year period) he/she must submit a renewal application. After the 2-year period, however, the student must resubmit all application materials, since files of students who do not enroll are discarded at the end of the renewal period. Admission in a previous semester does not guarantee admission in a new semester.

An application submitted without the appropriate fee attached will not be processed. Students applying to two fields of study need only submit one application fee. The application fee must be submitted in U.S. dollars only. You must submit an international money order drawn on a U.S. bank or check drawn on a U.S. bank for the

appropriate fee with your application. Make the check or money order payable to the "University of Hawaii". Include your full name, date of birth and social security number (if any) on the check or money order. The fee is non-refundable/non-transferable. Do not send cash. Any check tendered to the University and dishonored for any reason is assessed a \$15.00 returned check fee and interest charges at a rate of \$.10 per month or a fraction of a month.

- 3. Official transcript from each institution attended sent directly from each institution
- **4.** Official TOEFL scores (foreign and some immigrant applicants).

Applicants to the schools of Library Studies, Public Health and Social Work should submit the above items directly to those offices. Exception: All currently enrolled graduate students wishing to apply for a change in their field of study must submit the application directly to the Graduate Admissions Office.

GRE, GMAT, MAT scores, departmental official transcripts (if required), letters of recommendation, and special departmental forms should be submitted directly to the Chairperson of the field of study (See Degree Programs and Field of Study Requirements for listing of Departmental requirements beginning on page 6).

THE APPLICATION FORM

It is essential to complete all entries and to sign all forms. Falsification, withholding of information, or failure to list all schools attended may result in rejection of your application or disciplinary action if discovered after enrollment. Retain instructions for future reference.

- 1. Student Identification Numbers Use U.S. Social Security Number. Foreign applicants who have previously been assigned a U.S. Social Security Number by an employer or university must use that number. Those foreign applicants who do not have a number will be assigned a student ID number by the Graduate Division. (Refer to "Use of Social Security Number", page 5). Whenever possible, applicants should refer to their U.S. Social Security number or assigned Student ID number when corresponding with the Graduate Admissions Office.
- 2. Other Names: List any other names by which your transcripts, test scores, or other documents may be identified.
- **3. Ethnicity**: Each applicant is required to indicate his or her ethnic background. This information is requested solely for the purpose of satisfying Federal reporting requirements and does not affect determination of admission. Several Federal agencies require the University to provide summary data on the ethnic background of applicants. The ethnic designations used by the University for this purpose do not denote scientific definitions of anthropological origins. Rather, they are used to indicate a general group to which a person appears to belong or identifies with. Determine the one category which you believe best represents your ethnic background. Enter the alpha code.

- **4. Foreign applicant visa status.** This applies to foreign applicants currently in the U.S. Check the type of visa with which you entered the U.S.
- **5. Field of Study, Program Code, Degree Sought:** Write the name of the field, the corresponding program code, and degree sought exactly as it is listed beginning on page 6 under Degree Programs Offered and Field of Study Requirements. For example: Anthropology 305 PhD.
- **6. Multiple Applications** Applicants may submit applications to only **two** graduate programs per semester. Two separate applications must be submitted at the same time. Two sets of transcripts must be submitted directly from the issuing institution to the Graduate Division. Those admitted to both programs may pursue only one degree program. (Only exception: Those admitted to established dual degree programs.)

Dual Degree Programs: Information about dual degree programs can be obtained directly from the fields of study. See listing of programs on page 10.

7. Applicant's Certification: Read and sign the certification. Falsification, withholding of information, or failure to list all schools attended may result in rejection of your application or disciplinary action if discovered after enrollment.

Please copy all materials submitted as the application and all supporting documents become the property of the Graduate Division of the University of Hawaii at Manoa and will not be returned to the applicant, forwarded to another institution, or duplicated for any purpose.

Authorization for release of information: Your admission file is considered confidential and will only be discussed with you and the appropriate University of Hawaii faculty and staff. If you would like anyone else to have access to information on the status of your application, enter his/her name on the first page of the application, or submit a written statement giving your authorization and the person's name. Information on the status of your application may be obtained until it is ready for evaluation. Once the application is complete and being reviewed, information will not be available until the final letter of notification is sent by the Graduate Admissions Office.

TRANSCRIPTS OF ACADEMIC RECORD

Transcript Requirements: All transcripts of academic records must be official. Each applicant must submit one official transcript directly from each institution attended to the **Graduate Admissions Office**. Students need to contact the department to which they are applying for information regarding departmental transcript requirements. Transcripts are required from each institution attended, even if the credits appear as transferred credits on your records at another institution, and regardless of the number of credits earned or the length of time attended.

University of Hawaii graduate students enrolled within the last 5 years who are applying for admission to a different field of study may request copies of transcripts from institutions other than the University of Hawaii which are on file from a previous graduate application.

Contact the Graduate Admissions office for the appropriate request form

Official Transcripts: Transcripts of academic record must be official. Official transcripts are original documents issued by the college or university which bear the actual signature of the registrar in ink, and the embossed seal or official stamp of the issuing institution. Official documents must be mailed directly from the institution to the Graduate Admissions Office.

In countries where educational institutions will not issue transcripts to other institutions each time the student applies for admission (e.g., Bangladesh, India, Pakistan), applicants may submit typewritten facsimiles or photocopies of their academic record, provided they are attested true copies bearing the original signature of the registrar, asst. registrar, head of the department, dean of student affairs, or controller of examinations. Notarized credentials or certification by officials of government agencies, such as binational commissions and foundations abroad, attesting to the authenticity of the photocopied credentials are also acceptable and are considered official if certified with full name and title of the official of the agency.

Nontraditional Grading: If more than 25% of a student's undergraduate course work at U.S. institutions has been graded under a non-traditional grading system (e.g., pass/fail, credit/no credit, S/U, H/CR, no grades, etc.), the transcripts must be accompanied by official course performance reports or faculty evaluations and GRE general test scores. Accounting, Business Administration., and Travel Industry Management candidates may submit GMAT test scores instead of the GRE.

Foreign Academic Credentials All official academic records must be issued in the original language and accompanied by certified literal English translations. These translations must bear the embossed seal or inked stamp of the issuing institution or governmental agency and the original signature of the translator, and must be complete and exact word for word translations of the original documents. Numerical percentage grades must not be converted to letter grades. If the records do not include the institution's grading scale, or other system of evaluation including maximum and minimum marks, an official copy of the grading system must be submitted. All transcripts of academic records must be official. Each applicant must submit one official transcript directly from each institution attended to the Graduate Admissions Office. Students need to contact the department to which they are applying for information regarding departmental transcript requirements.

Academic records should list each course taken, dates of attendance, credits or hours, and grades received. If the title of the course listed is not descriptive in terms of content, a syllabus of the course of study should accompany the transcript.

If a degree, diploma, or other professional title awarded upon graduation is not entered on the transcript, an official copy of the certificate verifying the conferral of the degree or diploma and the date of conferral must be submitted along with the transcript. The name of the degree should be indicated exactly as it is known in the country of origin, and should not be translated or interpreted in terms of a U.S. degree equivalent.

Applicants from Bangladesh, India, Myanmar, Nepal, and Pakistan are required to submit official records for each year of study showing the subject included in each examination, the maximum mark in each subject, the minimum mark for passing, the mark obtained, and the "Division" or "Class" received. With the exception of holders of a 4-5 year B.Eng, B. Arch, B.Agri., B.Tech., or M.B.B.S. degree, applicants who have attended or are attending higher education institutions must present a completed master's degree at the time the application is filed.

Students studying in Commonwealth countries or under a system

of education which follows the British pattern (or a modified version) of examination and grading, where the classification for the degree (First Class, Second Class, etc.) is based on the final year examination, should apply after the degree has been awarded. This applies to students from Australia, England, Hong Kong, Malaysia, New Zealand, Singapore, Sri Lanka, and some African countries. An official certificate showing the degree awarded and the division must be submitted at the time the application is filed.

RESIDENCY DECLARATION

All applicants must complete the top section of the declaration, and sections A, B and H. Read the Residency Regulations below before completing the declaration.

Residency Regulations (condensed): Students who do not qualify as bona fide residents of the State of Hawaii, according to the University of Hawaii rules and regulations in effect at the time they register, must pay the nonresident tuition. An official determination of residency status will be made at the time of application. Applicants may be required to provide documentation to verify residency status. Once classified as a nonresident, a student continues to be so classified during his/her term at the college until he/she can present satisfactory evidence to the residency office that proves otherwise. Some of the more pertinent University residency regulations follow. For additional information or interpretation, or the complete rules and regulations, contact the residency officer located at the Office of Admissions and Records, University of Hawaii at Manoa 2600 Campus Road, Student Services Center, Honolulu, Hawaii 96822.

Definition of Hawaii Residency: A student who is a U.S. citizen or permanent resident of the U.S. is deemed a resident of the State of Hawaii for tuition purposes if the student (19* or older) or the student (under 19*) and his/her parents or legal guardians have:

- 1. Demonstrated intent to permanently reside in Hawaii (see below for
- 2. Been physically present in Hawaii for the 12 consecutive months prior to the first day of instruction, and subsequent to the demonstration of intent to make Hawaii his/her legal residency; and
- 3. The student, whether adult or minor, has not been claimed as a

dependent for tax purposes for at least 12 consecutive months prior to the first day of instruction by his/her parents or legal guardians who are not legal residents of Hawaii.

*The age of majority is 18 years. However, a person between the ages of 18 and 19, unless emancipated, cannot claim residency solely on the basis of himself/herself because he/she does not have the minimum 12 months residency, which commences on his/her 18th birthday. Therefore, the applicant must claim a portion of the required 12 months on the basis of his/her parents or legal guardians.

To demonstrate intent to make Hawaii your legal residence, the following indicia apply:

- A. Voting/registering to vote in the State of Hawaii.
- **B.** Filing Hawaii resident personal income tax return.

Other indicia, such as permanent employment and ownership or continuous leasing of a dwelling in Hawaii, may also apply but no single act is sufficient to establish residency in the State of Hawaii.

Other legal factors involved in making residency determinations include:

A. The 12 months of continuous residency in Hawaii shall begin on the date upon which the first overt action (see indicia above) is taken to make Hawaii, the permanent residence. Residence will be lost if it is

interrupted during the 12 months immediately preceding the first day of instruction.

- **B.** Residency in Hawaii and another place cannot be held simultaneously.
- C. Presence in Hawaii primarily to attend an institution of higher learning does not create residence status.
- **D**. The residency of unmarried students who are minors follows that of the parents or legal guardians. Marriage emancipates a minor.
- **E**. The residency of a married person follows that of the spouse.
- **F**. Resident status, once acquired, will be lost by future voluntary

of the resident inconsistent with such status. However, Hawaii residency will not be lost solely because of absence from the State while a member of the United States Armed Forces, while engaged in navigation, or while a student at any institution of learning.

Statutory Exemptions: Nonresident applicants in any of the following categories are eligible for waiver of the nonresident tuition differential (this means qualified to pay tuition at the resident rate):

- **A.** Hawaiians who are descendants of the aboriginal peoples that inhabited the Hawaiian Islands and exercised sovereignty in the Hawaiian Islands in 1778. (Submit an official copy of your birth certificate and, if necessary, that of your parents and grandparents, documenting your Hawaiian ancestry.)
- B. Persons who are legal residents of any Pacific Island or Asian district, commonwealth, territory, or insular jurisdiction, state, or nation which does not provide public institutions of higher learning. These include:

American Samoa Naura Marshall Islands, Republic of New Caledonia Micronesia (Federated States) Niue Northern Mariana Islands, Solomon Islands Commonwealth of Palau, Republic of Tonga Cook Islands Tuvalu Futuna Island Vanuatu Wallis Island

Kiribati

- C. United States military personnel and their authorized dependents (as defined by the U.S. Armed Services), during the period such personnel are stationed in Hawaii on active duty. Exemptions are subject to confirmation of status each year.
- **D**. Full-time employees of the University of Hawaii and their spouses and legal dependents (as defined under Internal Revenue Service
- E. East-West Center student grantees pursuing baccalaureate or advanced degrees.

Pacific-Asian Exemptions: Selected students from countries listed below may be eligible for resident tuition. A separate application for this exemption is not required. Determination is made on a case-bycase basis and is not automatic or continuous:

Misrepresentation: A student or prospective student who provides incorrect information on any form or document intended for use in the determination of residency status for tuition purposes will be subject to the requirements and/or disciplinary measures provided for in the rules and regulations governing residency status.

Appeal Process: Residency decisions may be appealed by contacting the residency officer for information on how to initiate an appeal before the Committee on Resident Status. Resident tuition may be paid when an appeal is pending.

SUPPLEMENTARY INFORMATION FOR NON-U.S. CITIZENS

Financial Status: All foreign applicants who are to be issued the I-20 or IAP/66 for their nonimmigrant visa (F and J) are required to give complete information on their financial status. Foreign applicants must complete all items on the Supplementary Information Form, and provide current official bank statements in **U.S. dollars** as proof of personal, sponsor or family funds. Bank statements must be original documents (photocopies are not accepted) certifying the amount available and not more than two months old from the date of submission. This is an important part of the application, since final admission to the Graduate Division is contingent upon proof of adequate funds.

TOEFL: All applicants whose native language is not English must submit an official TOEFL score report from a test taken within the last 2 years. The TOEFL is waived only for applicants who have completed a bachelor's or advanced degree program within the last five years at an accredited/recognized institution in the United States, Australia, Canada, New Zealand or United Kingdom. The program of study must be no less than two years of full time coursework. A score of 500 is required although most fields require higher scores as specified in the field of study requirements. Graduate teaching assistants must have a TOEFL score of 600.

An official TOEFL score report must be sent directly from the Educational Testing Service (ETS) to the Graduate Admissions Office (institution code 4867). Photocopies and applicant's "Examinee's Score Report" are not considered official.

STATEMENT OF OBJECTIVES

All applicants must complete this section. If more space is needed, write on the reverse side, or attach a separate sheet. A typewritten or word processed statement of objective is also accepted. A well prepared detailed resume may be submitted in addition to this statement.

FIELD OF STUDY REQUIREMENTS

Information on examinations, letters of recommendation, and other field of study requirements for admission begins on page 6. Detailed information about the requirements is available from the field of study. All test scores must be sent directly from the Educational Testing Center to the University of Hawaii (Institution code 4867) by the application deadline. Please do not file an application if you have missed taking any of the required tests which are applicable to you. Addresses for requesting information and test application forms appears on page 11.

ASSISTANTSHIPS, FELLOWSHIPS, TRAINEESHI

PS The University offers a number of graduate assistantships on a competitive basis to graduates of accredited institutions of higher learning who have satisfactory scholastic records, an adequate undergraduate background in the major field, and evidence of a high level of English proficiency. Graduate assistants serve as part-time teaching or technical assistants. Assistantships are also available in various fields in connection with research contracts or grants supervised by members of the faculty. All applicants for graduate assistantships must be admitted as potential degree candidates to qualify for appointments. Applications should be sent to the chairperson of the appropriate department before February 1. Each

application must be accompanied by three letters of recommendation from former professors or employers. Applications for assistantships are available from the field of study.

Students who have been awarded teaching assistantships (TA) should contact the Center for Teaching Excellence and Office of Faculty Development and Academic Support which offers a teaching assistantship training and orientation for all new and continuing TAs just prior to the first day of instruction. COMPLIANCE WITH FEDERAL LEGISLATION

Use of Social Security Number: Section 7(b) of the Privacy Act of 1974 (5 U.S.C. 522a) requires that when any Federal, State or local government agency requests an individual to disclose his or her social security account number, that individual must also be advised whether the disclosure is mandatory or voluntary, by what statutory or other authority the number is solicited, and what uses will be made of it.

Accordingly, each applicant is advised that disclosure of his or her social security account number (SSAN) is required as a condition for making application to any of the campuses of the University of Hawaii, in view of the practical administrative difficulties which the University of Hawaii would encounter in maintaining adequate student records without the continued use of the SSAN.

The SSAN will be used to verify the identity of the applicant, and as a student identification number throughout the period in which the applicant is enrolled, or otherwise associated with the University, in order to record data accurately. As a student identification number, the SSAN is used in such activities as: reconciliation of documents in order to determine eligibility for admission and residency for tuition purposes; registration and academic record-keeping; use of library materials; student affairs programs requiring verification of enrollment for the purpose of providing services, and alumni affairs.

Authority for requiring the disclosure of the applicant's SSAN is grounded in Section 304.2 and Section 304.4, Hawaii Revised Statutes, as amended, which provides that the Board of Regents of the University of Hawaii shall have general management and control of the

affairs of the University. The University of Hawaii has, for several years, consistently required the disclosure of SSAN on the admissions application forms and other necessary University documents.

In addition, it should be noted that the SSAN of a parent, guardian, or spouse, of an applicant is also requested if the applicant claims residency on the basis of the residency of the parent, guardian, or spouse. A parent, guardian, or spouse is advised that disclosure of his or her SSAN for the above purpose is mandatory. Failure to provide it may affect the applicant's admission to the University and the tuition charged the applicant when such applicant registers for classes. Parent's, guardian's, or spouse's SSAN will be recorded only on the Residency Declaration itself and will not be maintained in any other system of records. Its use will be restricted to further verification of information reported on the Residency Declaration by the applicant and/or parent, guardian, or spouse.

Students who intend to have their spouse and dependent children join them should consider carefully whether they have sufficient income to meet their needs as cost of living is very high in Hawaii and rental for family dwellings is expensive.
